A bidder shall submit their bid on-line.

The bids shall be submitted in electronic form in compliance with the conditions specified in the Tender Terms and Conditions.

## 7. Deadline for Bids submission:

The deadline for submitting bids will be specified in the call for bids submission.





#### 8. Deadline for Announcing the Selected Bid: 30.6.2026

The Tender Caller reserves the right to prolong the deadline for notification of the selected Bid.

## 9. Deadline and Place of Bids Evaluation:

The period for Bids evaluation shall start on the next day following the deadline for Bids submission and shall terminate on the day of announcement of the selected Bid.

The place of Bids evaluation is the Slovenské elektrárne, a.s., Závod: Jadrová elektráreň Mochovce, Obstarávanie MO34, 935 39 Mochovce

#### 10. The Manner of Selection of the Most Suitable Bid:

The Tender Caller chooses the bid which suits him best accordance to art. 286 Comercial Code.

#### 11. Other Information:

The Tender Terms and Conditions are available to bidders, who will provide within the deadline for the interest manifestation the following information: business name, address/registered office, country, for SK and CZ: company registration number, for EU: VAT number, for other countries: specific identification of organisation from relevant registry in home country, general contact information – telephone number, email, information of contact person: name and surname, telephone number, email.

Because the technical specification contains confidential information the documentation will be disclosed to bidders, who sign and submit the Non-disclosure agreement. A bidder signs Non-disclosure agreement, which is annexed to the Call. The tender caller will not negotiate the content of the Non-Disclosure Agreement and it is binding in the published wording. Scan of the signed Non-disclosure agreement has to be send to the email address of the contact person.

#### The deadline for submitting a scan of the signed Non-Disclosure Agreement is 9.12.2025.

If the bidder misses this deadline but submits a scan of the signed Non-Disclosure Agreement within the deadline for submission of bids, confidential information shall be provided, but the deadline for submission of bids will not be extended. The candidate should therefore take into account the need for sufficient time to prepare the offer after receiving the confidential information

A bid can be only submitted by a bidder who asked for the Tender Terms and Conditions in compliance with this item and who received them from the Tender Caller.

The Tender Caller, in line with Art. 283 of the Commercial Code, reserves the right to change conditions of this Tender or to cancel this Tender even without specifying any reason.

The Tender caller reserves the right to request further information confirming the real interest in Tender and the possibility of its fulfillment in case of the Tender caller's doubts about the real interest of the entity in the Tender based on the information provided while manifesting interest in the Tender.

The Tender caller reserves the right to not disclose the technical specification and/or Tender Terms and Conditions to such entity, which according to the provided information the Tender caller considers a person, who did not prove the real interest in participation in public tender.
